

RETURN POLICY

All sales final with the exception of damaged or inaccurate items.

Please send a refund request via email within 7 days of the item received. Please include your name, product name, and the reason why for your return. If your return is for an inaccurate or damaged item that was not listed prior to purchase, you will be sent a return label via email with further instructions. Please place the item back in its original packaging.

Refunds or exchanges will be distributed 1-2 days after the item is received.

Seller Terms

Berkshire Book Nook Consignment Agreement Berkshire Book Nook (Consignee) will accept books in good to excellent condition (no tears, no pages missing, spine intact, no excessive writing in the book, etc..) to be sold on "Berkshire Book Nook". The price will be set by Berkshire Book Nook as determined by fair market pricing, depending on the condition and popularity of the book and other items. Bad to fair conditioned books may be donated to Berkshire Book Nook. The following will be the payout to consignors for books sold: Paperback books- 30% Paperback special editions- 40% Hardcover books- 40% Hardcover books special editions- 50% Textbooks older than 2 years- 30% Textbooks 2 years or newer- 60% Accessories (bookmarks, book lights etc.)- 20% Once Berkshire Book Nook receives the items, they will be assessed for condition and priced accordingly. A statement will be sent out to the consignor detailing what items have been accepted for consignment and the price set for its sale. For any items that are not accepted, the Consignor has the option to have the Items returned to them or donate them to Berkshire Book Nook. **If an item is not sold after 6 months the price will be reduced 25%. **If an item is not sold after 1 year the consignor has the right to take back the items at no cost to them or donate the book to the store. The consignor may take their items back at any time with no penalty.
